



The department is led by Paul Weckman, a veteran who held several leadership positions during his more than 26 years of distinguished active duty service in the US Navy. A retired captain, Weckman was honorably discharged from the Navy in 2011.

"Sanford's dedication to raise the bar and to innovate without hesitation reflects courage and a commitment to service," said Weckman. "The support for this program has been outstanding. Sanfrod is devoted to providing the best possible experience for our veterans, military members and their families."

The Sanford Health Department of Veterans and Military Services helps veterans and military personnel obtain health care services, navigate care & insurance coverage, identify wellness services and search for employment opportunities. It also offers family support services and veteran community outreach.

Sanford Health is also participating in the Employer Support of the Guard and Reserve, or ESGR, program. This program supports the military services of employees and advocates for employee participation in the military.

"We're finding out that when a veteran comes in and sees a fellow veteran who is a provider or a nurse, the anxiety level goes down and they're going to be able to be more open about how things are going," said Weckman. "We want to ensure when they leave they feel we've done a good job of taking care of them."

# Chamber Now Accepting Applications for 2019 Leadership Program

2019 is going to be a great year and we are excited to kick it off right with the 33rd Annual Leadership Aberdeen program! Leadership Aberdeen 2019 is a great opportunity for individuals to develop leadership skills in a fun, friendly, and fast-

paced environment. The program provides participants with a good balance of personal leadership training and community education. We achieve that by exposing them to the "Positive Leadership" curriculum as well as speakers and organizations that challenge what they know about leadership and encourage them to make a difference within their company, community and state. Leadership Aberdeen provides participants with the opportunity to sharpen their skills, share their experiences, and make life-long connections with fellow participants.

Participants also tour a number of local businesses and have the opportunity to learn from their CEO's and staff on company philosophies, goals, and success stories. Plus the class gives back to the community by facilitating a local project or event that will have a positive impact on the Aberdeen community. Here is a list of the incredible projects and events that were facilitated by Leadership Aberdeen participants since 2004:

2004: The class originated the "Shoot for the Stars" Special Olympics Basketball Game. The class organized a community basketball game where Aberdeen "celebrities" played against the Special Olympics team to give them practice before their state tournament. The event raised money for Special Olympics and the event continues to this day with Thrivent as a major partner.

2005: The class hosted a "Taste of the World" event where different foods from different cultures were highlighted as way to help the community be more understanding and welcoming of different cultures.

The event raised approximately \$1,600 that was donated to the Dacotah Prairie Museum

2006: The class hosted the "Community Cares Music Fest" at Presentation

College's Strode Center and featured nine local musical acts from grade school groups to adults. Close to \$2,000 was raised by admission tickets and presented to local military troops and their families.

2007: The class used information compiled by Catalytix to engage young people and showcase what our community had available to them. The SOAR event (Students, Opportunities, Activities and Resources) was held at both Aberdeen middle schools and close to 35 organizations promoted what they had to offer to students.

2008: The class organized a "Link to Life" event that was held in conjunction with the Spring Job Fair. The class served as community ambassadors, visiting with job seekers on resources and opportunities available to them in Aberdeen. Aberdeen continues to have a booth at each job fair which showcases the community.

2009: The class project was "Pay it Forward" and focused on securing volunteers for community service clubs and organizations. The class organized a service club fair in conjunction with the Great Outdoor Show in an effort to get more people volunteering in the community.

2010: The class held an event called "All About Aberdeen: Discover the People, Discover the Fun" where they set up a carnival-type atmosphere which included games, snacks and prizes. It was held at Roncalli Elementary School and was designed to bring the community together to have fun and find out what Aberdeen has to offer families.

2011: The class hosted an event called "A Tall for Them All" which was a kick-off for the newly formed Sidekicks mentoring program. The



class raised money for the program and secured "talls" (mentors) and "smalls" (youth participants).

2012: The class worked with Volunteers of America Dakotas to develop The Children's Closet. They physically set up the store with donated items from the community and donated funds to the organization. The VOA used the closet as a way to incent and assist program participants.

2013: The class held a "SNOLF" Snow Golf Tournament at Wylie Lake to raise awareness and money for juvenile diabetes. The class donated over \$8,000 to Camp Gilbert from business donations and team registration fees.

2014: The class held "A Goal For Safe Harbor" event to raise funds for the Safe Harbor new building campaign and to raise awareness of Domestic Violence. The class held the event during an Aberdeen Wings Games and raised more \$35,000 through business donations, the shoot out and raffle.

2015: The class opened the "Help Build It Center" for Hub Area Habitat for Humanity. The store sells donated construction and household renovation items. They raised over \$6,000 to go towards the center and to help the organization to build Habitat homes in our area as well as other habitat for Humanity programs.

2016: The class raised over \$16,000 for Spurs of Aberdeen. They held a "Horse Pie Bingo" event, bake sale and raffle. Spurs used the funds to build a barn and corral at their facility. The group was also able to work with local companies and contractors to donate time and equipment for the building project.

2017: The class hosted the 1st Annual Day of Distinction on Friday, April 21, 2017 to a crowd of over 250 people. The Day of Distinction provided an opportunity for people in the Aberdeen area to gather with their peers and listen to five locally and nationally recognized speakers for personal and professional development. The theme was "Build It Up" and the topics focused on community engagement and responsibility. The class donated \$1,000 to the Boys and Girls Club.

2018: The Class worked with local artists to refurbish "ghost advertising signs" in the downtown Area. The project, Signs of the Times, began in May with six signs completed to date.

A big part of the program's success is due to the partnerships we have with local businesses who host

the sessions and help offset program costs. Those partners include: 3M Company, Avera St. Luke's, Molded Fiber Glass Companies, Glacial Lakes Energy, Sanford Health, Agtegra, Dacotah Bank, and Northern State University. We thank them for their continued support of this program and for helping build leaders in our community.

If you're interested in attending, or sending someone from your business, Leadership Aberdeen tuition for the 12-week program is \$750.00 for Aberdeen Area Chamber of Commerce members and \$900.00 for non-members. Tuition covers all program costs, including materials, meals, Aberdeen attire, lodging

and transportation while the class attends Aberdeen Day in Pierre, SD. The program will start January 10th and goes through March 26th and participants are expected to attend all sessions in the belief that everyone brings their unique experience to the program. The majority of sessions are held Tuesday evenings from 5-9 pm. The schedule is available online.

# Aberdeen Visa Gift Card - Get Ready for the Holidays

Hi, this is Bea with the Aberdeen Area Chamber of Commerce. With the holidays fast approaching, we want to make sure you and your staff are ready to accept the Aberdeen Visa Gift Card at your business! Here are a few reminders

about accepting the card...


- ONLY Chamber members in good standing can accept the card. This is a benefit of your membership.
- If you have updated or upgraded your POS system in the last couple of months, please call us at (605) 225-2860 and we will come out to re-activate your system. It takes just a few minutes, but will allow you to once again accept the card.
- Determine the balance on the customer's card BEFORE taking it as payment. If the customer does not know their balance, they can call

1-800-755-0085 or go to http://www. getmybalance.com/

Process payment as a VISA Card only. If the customer's bill is less than the balance on their card, just run the card for the full amount. If their bill exceeds the balance on the card, do a splittender transaction. For example, if the customer owes \$75,

but only has \$50 on their Aberdeen card, ask for a \$25 payment in whatever method they prefer (check, cash, or another card) and process that first, then swipe the Aberdeen card for \$50.

- If you need to void a transaction, handle as you would any other VISA card void. However, if you have any difficulty call 1-800-755-0085.
- If an item is returned that was purchased, you can credit it back to



the Aberdeen Visa Gift Card or issue an in-store credit.

 Lastly, if you have any difficulty, please call our office at (605) 225-2860 and we can help you through the transaction. Or, if you would like us to stop out and go through details of the program with you and your staff, we are happy to do that too! Call us at (605) 225-2860 or email: info@aberdeen-chamber.com

# Groundbreaking Held for New School for the Blind

More than 100 people attended a groundbreaking ceremony for the new South Dakota School for the Blind and Visually Impaired on Oct. 17.

Numerous SDSBVI students and staff members attended the groundbreaking, as well as Gov. Dennis Daugaard, city officials, representatives of Northern State University, and others involved with the project. The ceremony was held in the parking lot north of the former site of Jerde Hall, with a reception afterward in the Barnett Center lobby.

The new School for the Blind and Visually Impaired is one of three projects of the Educational Impact Campaign. The \$45 million campaign,

a collaborative effort between Northern and SDSBVI, has already received pledges totaling \$35 million.

The new SDSBVI facility will be constructed at the former Jerde site, with

a projected completion date of fall 2019.

The other two projects of the Educational Impact Campaign are the new NSU Athletic and Recreation Fields and an on-campus regional sports complex, which includes Dacotah Bank Stadium and Koehler Hall of Fame Softball Field.



Northern broke ground on the Athletic and Recreation Fields project in April, and the fields opened for the fall 2018 athletic season. Once SDSBVI has moved into the new school, its current facility will be demolished and work will begin spring 2020 on the regional sports complex, with completion expected by 2022.

# Gifts of Commodities to Qualified Charitable Organizations

Considered the most significant tax code overhaul in over three decades, the Tax Cuts and Jobs Act was passed by Congress on Dec. 20, 2017, and signed into law by President Trump on Dec. 22, 2017. It includes provisions affecting both

individuals and businesses, and while simplifying taxes for some taxpayers, it has created new complexity for others.

### **Standard Deduction Increases**

It has been estimated that nearly 90 percent of individual taxpavers will now utilize the Tax Cuts and Jobs Act increased deduction capabilities of the standard deduction. Not including additional standard deduction amounts for the blind or elderly, the Tax Cuts and Jobs Act increased the standard deduction for a couple electing to file "married filing joint" from \$12,700 in 2017 to \$24,000 in 2018. Additionally, the standard deduction for a single taxpayer increased from \$6,350 in 2017 to \$12,000 in 2018. The increase in the standard deduction amounts alone will likely generate enough tax savings to switch many individual taxpayers from claiming itemized deductions, but the law's limitation. or complete elimination, of certain itemized deductions enhances that likelihood.

### Impact on Charitable Contributions

The most commonly used itemized deductions include state and local taxes, home mortgage interest, and charitable contributions. With the standard deduction almost double the amount of prior years, the decrease in taxpayers claiming itemized deductions is expected to have an impact on charitable giving, primarily because the incentive to make a charitable contribution and receive a tax deduction will be gone for many taxpayers. However, in many cases, it may not matter. Individuals should give because they are passionate about the causes that charitable organizations support, not just because they will

save money on income taxes. But, in those cases where the deduction does matter, better planning for those who wish to donate will make it much easier to realize a tax benefit.

### **Gifting Commodities**

For example, how have these new changes affected the agricultural community when gifting commodities? Cash basis producers still have the ability to make contributions of raised commodities directly to a charitable organization. The fair market value of the gifted commodity is excluded from taxable income of the donor, resulting in the potential for significant federal, state and self-employment tax savings. This is true even though no charitable deduction is allowed, as the tax basis of the commodity contributed is zero.

How does this strategy work to provide the maximum tax benefit? To achieve the desired results, it is very important that the following rules are followed:

- 1. The donor must be a cash basis farmer, who is actively engaged in a farming activity.
  - a. Commodities gifted by an accrual basis farmer will not qualify.
  - b. Grain gifted by a cropshare landlord does not qualify due to the assignment of income principal.
- 2. The donor must be sure that commodities gifted are not:
  - a. Collateral for a CCC loan.
  - b. Under a loan deficiency payment contract.
- 3. The donor must ensure that the commodity, not cash, is being given to the charitable organization.
  - Clear title to the commodity must pass to the charitable organization.
  - b. The title requirement can be evidenced by an assembly sheet or warehouse receipt in the name of the charity. When the donor delivers grain to the elevator, the producer must use the charity's name on the assembly sheet.
  - c. The assembly sheet or warehouse receipt should be delivered to the

- charitable organization with a letter indicating that the commodity has been donated and that the charity is now the owner of the commodity and has total control over the commodity, including the ability to sell it at any time.
- 4. The charitable organization must direct the sale of the commodity, as the donor is no longer the owner. Therefore, if the charity wants to cash out a commodity donation, the charity must call the elevator, not the donor, to request the commodity to be sold.
- 5. If the commodity is delivered by a producer to a cooperative, the reporting of the commodity sale will be handled differently. Under normal circumstances, the sale of commodity by the producer will generate unit retains as reported on the 1099-PATR. Because the commodity is not being sold in the producer's name, the bushels sold and dollars collected should not be included on the producer's 1099-PATR. However, it is important for the producer to keep a copy of the assembly sheet for the commodity donated to the charity to be able to prove their yields for FSA and crop insurance purposes. Also, it is important to review your 1099-PATR at the end of the year in which you make a donation to be sure the commodity sale was not included in your taxable total.

Remember, if the above steps are not followed, the IRS may treat the commodity donation first as a grain sale by the farmer, and then a subsequent cash contribution to the charitable organization, which is not the best result for the farmer.

The example above is just one of many that need to be considered when planning gifts to charitable organizations. To maximize your benefits and reduce the risk of unintended consequences, consult with your tax professional to discuss this or other strategies for charitable giving in the new era of taxation under the Tax Cuts and Jobs Act.

# Do I Really Need a Business Plan?

Some people think that the business plan is "just paperwork that the bank makes me do to get a loan." Nothing could be farther from the truth; the primary beneficiary of a business plan is the business itself.

Putting a business plan

together does not have to be difficult; you already know a lot about your business so start by committing that to paper. Though formats vary, most plans address topics such as a description of your business and industry, the management team and their expertise, the personnel positions and skills needed, products/services offered, customer base (size, location,

characteristics), competition, future trends affecting the business, and marketing plans for the business. A discussion of financial information including initial startup costs as well as ongoing sales forecasts, costs of goods sold, operating costs, debt service, and projected financial statements are a very important part of the plan.

Business plans can be used as financing proposals, marketing plans, strategic plans, operational plans, and feasibility studies. The length and detail of the plan depends on its intended use. The business owner needs to take the lead in the planning process. After all, it is your business; you have knowledge and insight that no outsider has. Be sure to include the Small Business Development Center on your team as well. Having an independent advisor with experience in business planning can give you

valuable insight and make sure your plan is solid and ready to share with lenders and others. We can also help you develop forecasts so you can consider the financial feasibility of the project.

Having a plan alone does not guarantee success; but it can help you be better prepared to deal with unexpected happenings. It can also help you make better daily decisions and choose opportunities that fit with the plan. Planning takes some time and is an ongoing process, but in the long run, the benefits outweigh the costs.

# CivicReady Added to City Website

The company responsible for the development, hosting and maintenance of the city's website is called CivicPlus. CivicPlus has more than 20 years of experience focused exclusively on working with local government. Local government websites created

by CivicPlus have registered over 2 billion page views, and collected 30 million plus website searches with the client base of 3,500 local government entities

The City of Aberdeen recently purchased a module from CivicPlus that is called CivicReady. CivicReady is a mass and emergency notification system that integrates with the Federal

Emergency Management Agency, which is commonly called FEMA. FEMA created an Integrated Public Alert and Warning System (IPAWS) in 2006. IPAWS is a notification tool that allows authorized users to connect to the IPAWS platform to send alerts to cell phones, local TV and radio broadcast, and can even post notifications to digital road signs and various other locations instantaneously. IPAWS enables the city to reach as many people as possible, including citizens and visitors who have not opted-in to text, phone or email communications. The City of Aberdeen started the application process in May of 2018 to become an IPAWS user after completing a certificate of achievement in course studies through FEMA and was recently granted authority to operate.

Key Benefits of IPAWS Alert include the following:

Can be delivered to all

members of the community without needing to have their contact information in the city's database.

- Simultaneously send Wireless Emergency Alerts (WEA), Emergency Alert System (EAS) and Non-Weather Emergency Messages (NWEM) to reach members of the community via cell phone, television and radio.
- Deliver targeted IPAWS alerts to citizens located within a specific geographic area by selecting the region on a map.

IPAWS can be used to communicate any kind of threat to the public. Without doubt, the possible utilization of IPAWS provides an effective way to alert the public, but one can only hope the need or threats to the public is limited.

# Workplace Rights During and After Pregnancy

This fall I watched my five year old daughter walk into her kindergarten class, wearing a Trolls backpack that was nearly bigger than her and pink lunchbox in hand. It is hard to believe than just five short years ago she was a tiny infant and I

was working hard to balance the life of an attorney and mother to a newborn and a preteen. The demands of work and family are hard enough as it is, without the added worry of losing your job or position at work. If you are pregnant, have been pregnant, or may become pregnant, you have legal rights under federal law.

1. PDA: The Pregnancy
Discrimination Act (PDA) prohibits
discrimination against employees
and applicants on the basis of
"pregnancy, childbirth and related
medical conditions." Any employer
that is subject to Title VII of the Civil
Rights Act of 1964 (i.e., has 15 or more
employees) must comply with the
PDA. The pregnancy discrimination
law requires employers to treat
pregnant employees the same as other
employees on the basis of their ability
or inability to work.

2. FMLA: When an employee becomes pregnant, employers must consider her right to take Family Medical Leave Act (FMLA) leave.

The FMLA provides up to 12 weeks of unpaid leave. To qualify for FMLA leave, an employee must have worked for the same employer for at least 12 months (not necessarily continuously) and clocked at least 1,250 hours of service (slightly more than 24 hours per week) during the 12 months leading up to FMLA leave. Any organization with 50 or more employees working within a 75-mile radius of the work site must comply with the FMLA. Fathers are generally entitled to FMLA leave as well following the birth of a child.

**3. ADA:** A normal pregnancy is not considered a disability under the Americans with Disabilities Act (ADA). But if a woman experiences pregnancy complications that substantially limit a major life activity, she may be considered disabled under the ADA and, therefore, entitled to reasonable accommodation to perform her job or leave from work for a certain period of time. All employers with 15 or more

employees must comply with the ADA. An employer cannot legally fire you, or refuse to hire or promote you, because you asked for an accommodation, or because you need one. The employer also cannot charge you for the costs


of an accommodation. Because employers do not have to excuse poor job performance, even if it was caused by a pregnancy-related medical condition, it may be better to ask for an accommodation before any problems occur or become worse.

**4. Employee Policies:** In addition to any leave required under the PDA, FMLA, or ADA, employers may also provide for maternity leave under their employee policies. These policies must be applied uniformly, so as not to create discrimination in practice between similarly situated employees.

If you believe you are not being treated fairly at work, start by telling a supervisor or the HR manager. If the problem still persists, the EEOC could help you decide what to do next, and conduct an investigation if you chose to file a charge of discrimination.

# Hitting Our Numbers

On Sept.
20, per Board
of Regents
policy, Northern
State University
announced its fall
enrollment numbers.
While our overall
headcount was
down slightly, 3,493
students this year
compared to 3,611
in fall 2017, many
factors pointed

to encouraging signs of positive momentum on campus. Here are a few: **High School GPA** 

This year's group of first-time, full-time, bachelor's degree-seeking students has an average high school GPA of 3.431. Our data only goes back so far, but that is the highest high school GPA for a Northern cohort in at least 10 years. It's likely one of the highest high school GPAs for a Northern class ever. When managing a university's enrollment, it is important that quantity doesn't affect quality, and this year's numbers showed an increase without sacrificing academic quality.

### **Larger Freshman Class**

Northern has 339 freshmen this year, nearly a 5 percent increase from fall 2017. Our goal was 340. It's important to hit this goal, as first-time freshmen take the vast majority of Admissions' time and resources. This group historically lives on campus, works in the community and patronizes local eateries. It's also the group that Northern will continue to focus on increasing, as our goal for 2019 is more than 340 new freshman.

### Retention

Our freshmen to sophomore retention rate, the rate at which freshmen continue their studies at Northern, remained historically high at 75 percent. This is the first time in at least 20 years that Northern has had three years in a row of retention rates over 70 percent. This is incredibly important for enrollment; since Admissions spends months and years recruiting students, we need to do our very best to keep them here and in our community. Our campus goal for retention is 80 percent (which rivals private institutions), and every person on campus plays a part. We're extremely proud of this metric, but we know our work is never done.

### **More Graduate Students**

In addition to more freshman students, we saw a 71 percent jump in the number of first-time, degreeseeking graduate students. We are always looking to expand our graduate offerings, including a proposal for a master's program for teachers of the visually impaired – part of our

collaboration with the South Dakota School for the Blind and Visually Impaired. If you or anyone you know is interested in furthering their education, have them email gradstudies@northern.edu.


### Tops in Keeping Graduates in S.D.

According to a Board of Regents analysis, Northern leads the way among BOR institutions in keeping graduates in South Dakota, with 66.3 percent of NSU's undergraduate degree-earners employed in state after graduation. The average of the other SDBOR institutions was 60.9 percent. This is one way Northern contributes more than \$229 million of annual economic impact to South Dakota, per a SDBOR 2016 economic report.

I'm proud of the work the Admissions team, our coaches, faculty and staff did this past year, but we are far from done. There is always a sense of eagerness when your livelihood depends on the decisions of 17-year-olds, but this is our trade. Seeing new students start their educations, work through classes and then graduate is the most rewarding part of my job.

We owe it to our community and region to unleash a steady stream of talented and work-ready graduates. I'm confident we will meet that challenge.
